FACULTY COUNCIL REPRESENTATIVE TO THE BOARD REPORT

- Anne Ruszkiewicz
 - Reported
 - Faculty are happy to be back on campus and teaching face to face.
 - Work continues with Middlestates, new ILO's and assessment and the new Gen Ed Requirement
 - Faculty Council meeting on September 28th, Dr. Kenneth Luck is the new Secretary.
 - New food service company is a big improvement.

MSCHE Self Study Update

Dr. Jeffrey Keefer gave an update on the MSCHE self-study. The draft self-study design was submitted to Melissa Hardin, the MSCHE liaison. Her virtual campus visit is tomorrow, she will have several meetings throughout the day that include meetings with the President, Steering Committee, Students/Faculty/Staff, and the BOT. The purpose for her visit is to get to know more about the campus and discuss the Self Study design that was submitted. The seven standard working groups have begun to identify and collect evidence.

CHAIRMAN'S REPORT

- Dr. Hackett stated that angst among community colleges and their enrollment is evident in NYCCT group.
- SUNY Sullivan has done a tremendous job in finding additional ways to enrich the community and to create connections with additional organizations in the community.
 TSTT, Todays Students Tomorrows Teachers is an example of this.
- Safety on campus is always at the forefront of what we do but the college has done a
 great job in keeping everyone safe. Thank you to Nancy McGraw at Public Health and
 our Faculty, Staff and Students.

Presidents Report:

- Jay Quaintance, President
 - Reported
 - Introduced Nichole Connal our newly elected Student Trustee who officially join the board after she is sworn in at the county next week. Nichole is an Environmental Science Major, in the Garden Club, a Sullivan Renaissance Scholar, participated in the Bridges to Baccalaureate Program and very involved in campus activities.
 - Reopening campus has been smooth, thank you to the entire campus for all of their hard work.
 - We've had a few positive cases but 0% transmission on campus.
 - SUNY Student Vaccine mandate has gone into effect, we've been working to get everyone vaccinated. Our total unvaccinated students is down to 103 which makes up approximately 90% compliant. The grace period was extended for a short period of time, all students must be vaccinated by October 7th or they will be administratively withdrawn with no refund.
 - 90% of Employees are vaccinated.
 - Current Enrollment is at 90% of where we were this time last year. We have a new recruitment/marketing plan and a draft retention plan.

- BOCES students will return to campus on October 12th. BOCES will provide an attestation for each class that all students coming to campus are vaccinated.
- SUNY Counsel has stated that all learners must follow the vaccine mandates which includes Community Learning Classes and any professional development events we host on campus for schools.
- Energy Project Update-Three new boilers arrived and will be installed soon as well as additional upgrades that continue. Thank you to Larry Reeger and Rich Butler for all of their hard work in coordinating these efforts.
- EV Charging Stations are still in the works, they are awaiting permits through the County.
- Daycare is Open with 7 seats now available for Community Students.
- The expanded Food Pantry is open and now includes fresh produce from the Community Garden and Hope Farm. Thank you to Deb Waller-Frederick and Kathy Scullion for all of their hard work. We have a Ribbon Cutting Ceremony planned for October 22nd.
- Welcome Quazi Rahman our new Director of Institutional Technology
- Vice President for Academic and Student Affairs search is underway

President Quaintance shared one additional item for the Board to review and vote on, Policy on a Vaccine Mandate for Managerial Confidential Employees and non-union staff. The policy states that all MC and non-union staff would need to begin the vaccination process to be vaccinated against COVID-19 by October 15th with the intention of receiving a second dose depending on which vaccine they choose. This aligns with the SUNY policy that was enacted last week for MC employees.

- T. Hamlin asked how many people are not currently vaccinated. J.Quaintance shared that 9 people will fall under this mandate, 3 of which are MC's.
- J. Quaintance stated that this is being presented to the board as a policy rather than a resolution because we do not know how long this mandate will need to be in place.

Motion by J. Kane to support the policy "COVID-19 Vaccination Requirement for Managerial Confidential Employees and Employees Not Covered by a Collective Bargaining Agreement," through a board vote, seconded by P. Guenther and passed.

- P. Coombe asked who is paying for the pool testing. J. Quaintance shared that the college is paying for the testing but is tracking it for a FEMA application.
